

Government Guidelines

HHS extends the COVID-19 Public Health Emergency and maintains provider flexibilities

The U.S. Department of Health and Human Services (HHS) officially renewed the public health emergency declaration (PHE) for the coronavirus pandemic. The emergency declaration will now last through October 23, 2020 (at least). This will ensure that key telehealth flexibilities and cost sharing waivers for COVID-19 testing and treatment remain in place for at least 90 more days as many states are facing dramatic increases in COVID-19 cases.

The Massachusetts Medical Society (MMS) supported many HHS flexibilities adopted during the PHE and advocated to make the [telemedicine policies permanent](#). However, we have urged the Centers for Medicare and Medicaid Services (CMS) to sunset the PHE waivers involving scope of practice and licensure when the PHE concludes. The MMS, the American Medical Association (AMA), and several state and specialty societies [sent a letter this week](#) to CMS Administrator Seema Verma affirming our support for the

physician-led team-based approach to care and opposing efforts that could undermine the physician-patient relationship during and after the pandemic.

Public Health

Massachusetts travel order effective August 1

Starting on August 1, all travelers entering the Commonwealth, including both out-of-state residents and Massachusetts residents returning home, must fill out a “Massachusetts Travel Form” and quarantine for 14 days, unless they are coming from a COVID-19 lower-risk state or they can produce a negative COVID-19 test result administered no more than 72 hours prior to arriving in Massachusetts. Failure to comply may result in a \$500 fine per day. Travelers are exempt from this requirement if they are coming from a designated lower-risk COVID-19 state or fall into another narrow exemption category. Lower-risk states currently include: New York, New Jersey, Connecticut, Maine, Rhode Island, Vermont, New Hampshire and Hawaii, but is subject to change at any time. Patients who are traveling to Massachusetts to seek or receive specialized medical care from a physician located in the Commonwealth are also exempt. Practice Management

Application extension: Provider Relief Funds for Medicaid and CHIP physicians and organizations

The U.S. Department of Health and Human Services (HHS) extended the deadline for eligible Medicaid and CHIP physicians and organizations to [submit information](#) and apply for funding from the CARES Act Provider Relief Fund to August 3, 2020 (originally July 20).

HHS is distributing approximately \$15 billion to eligible physicians who have not previously received a payment from the Provider Relief Fund. The payment amount will be at least 2 percent of reported gross revenue from patient care, and the final amount will be determined based on submitted data, including the number of Medicaid patients served. HHS created a [fact sheet](#) to explain the application process and answer frequently asked questions.
