A member of the Society since he was a medical student in 1998, he is the youngest president to serve the MMS. Dr. Rosman is committed to global health and to addressing disparities in health care and started the first-ever radiology residency in Rwanda. He earned his BA cum laude in economics and philosophy from Dartmouth College, his MBA in health care, business, and public policy from the Wharton School of the University of Pennsylvania, and his MD from the University of Massachusetts Medical School.
