Dear Chair Michlewitz, Chair Rodrigues and Honorable Committee Members:

The *t*MED Coalition and its members wish to express its gratitude and appreciation for the funding to support equitable and affordable broadband adoption, infrastructure improvements, and digital literacy programming to close the digital divide included in both **HB.4234** and **SB. 2564**, **An Act Relative to Immediate COVID-19 Recovery Needs**. As a coalition that advocates for expanded access to telehealth services, we have noted significant barriers in accessing such care for communities that lack digital literacy. This is of particular importance from a health equity perspective, especially as telehealth grows in its utilization. Initial statewide data indicates that the utilization of telehealth for certain patient populations increased by 5,100% in March 2020 when compared to March 2019<sup>1</sup>. The digital divide ultimately results in a healthcare divide.

To address this existing and likely growing disparity, the *t*MED Coalition **respectfully encourages you to support the language adopted by the House in section 4 of HB4234 in lines 1384-1386 that seeks to expand digital literacy for residents experiencing economic hardship including those who have taken advantage of the federal communication commission's (FCC) emergency broadband benefit program and the FCC's lifeline program.** This language would prioritize funding for those populations who have experienced increased barriers in accessing healthcare and telehealth services, including those disproportionately affected by COVID-19, the elderly, patients of color,<sup>2</sup> and those who may need assistance with telehealth services due to limited English proficiency or limited literacy with digital health tools. From a provider perspective, there is tremendous clinical benefit to patients and administrative benefit to practices in having increased technological and other support available to patients accessing care via telehealth and ensuring that they are literate in the use of these devices with the goal of improving their own health.

Thank you for your time and your consideration of this matter. We appreciate the Legislature's thoughtful deliberation regarding the use of ARPA funding and for your consideration of these funds as an important intervention for health equity for our patients.
