| <p><b>“Appeal”</b></p>                                                  | <p>Belief that the chair is mistaken in a ruling and that the assembly should decide.</p>                                                                                                                                                                                                                                                                                                                                                                                |
| <p><b>“Parli’ inquiry”</b></p>                                          | <p>A question about parliamentary procedure that needs an immediate response.</p>                                                                                                                                                                                                                                                                                                                                                                                        |
| <p><b>“Factual inquiry”</b></p>                                         | <p>Request for substantive information.</p>                                                                                                                                                                                                                                                                                                                                                                                                                              |
