Member Type	Annual State Dues
New Physician*	\$200 + District
Community Health Care Physician†	\$200 + District
Resident/Fellow‡	Free or \$60 + District
Medical Student	Free

*New members and those whose membership has lapsed more than two years qualify for our \$200 introductory state medical dues. Regular dues: \$450 + District.

†\$200 new and reoccurring state dues are for physicians whose primary place of employment is a community health center recognized by the Massachusetts League of Community Health Centers.

‡Residents and fellows who enroll as part of an accredited training program are eligible for FREE membership. Four districts require nominal resident member dues.
